## A PROCLAMATION DECLARING THE 200 YEAR ANNIVERSARY OF GREEK INDEPENDENCE DAY

WHEREAS, Greeks all over the world celebrate Greek Independence Day every year on March 25<sup>Th</sup>.

WHEREAS, March 25, 2021 will be the 200 Year Anniversary Celebration of Greek Independence since the Greeks got their freedom from the Ottoman Turks in 1821.

WHEREAS, the early Greek Immigrants that came to White Pine County came via the construction of the Nevada Northern Railway as workers building the railroad.

WHEREAS, the July, August, and September 1906 railroad payroll records show 117 Greeks working as predominantly Section Laborers on the railroad for \$1.75 to \$2.50 a day.

WHEREAS, on September 29, 1906 when the railroad reached the Ely Depot, the Greek laborers came into Ely to witness the celebration.

WHEREAS, on December 7, 1906 when ground was broken for the building of the smelter and the mill in the Town of McGill, the Greek Immigrants joined the workforce, where they worked nine hour shifts and were paid \$2.25 to \$2.50 a day.

WHEREAS, in 1907 the Greeks working in the mines were earning \$2.75 to \$3.00 a day.

WHEREAS, in the 1910 Census there were 696 Greeks living in White Pine County, where the majority were working as laborers in the smelter, mill and the mines.

WHEREAS, some of the Greek Immigrants became entrepreneurs and opened bakeries, general merchandise stores, barber shops, coffeehouses, and butcher shops.

WHEREAS, the Greek Immigrants lived, owned businesses and raised their families in the communities of Kimberly, Riepetown, Old Ruth, McGill, Ely and East Ely.

WHEREAS, the Greek families today continue to live in Ely and the surrounding communities where they live their lives with the customs their family members brought with them over 100 years ago, from their mother country of Greece.

NOW, THEREFORE, I, Nathan Robertson, Mayor of the City of Ely, do hereby proclaim Thursday, March 25, 2021, as:

### Celebration of the 200 Year Anniversary of Greek Independence

in the City of Ely, and we welcome all citizens of Ely and the surrounding communities to join in the 200 Year Anniversary of Greek Independence Day, and the celebration and remembrance of the Greek Immigrants who lived and took part in the creation and development of our City and neighboring communities.

The following comment on the White Pine Pumped Storage Project draft environmental Visual and Aesthetic Resources Study; Preliminary Jurisdictional Determination Study; Rare, Threatened, and Endangered Wildlife Species Assessment Recreation Resources Study; Special-Status Plants and Noxious Weeds Study; and Cultural Resources Study was approved by the Ely City Council at the regular meeting held March 25, 2021:

First and foremost, it is the City of Ely's position there needs to be public meetings to discuss and describe this project to the masses and not just to local government officials. The public has a right to be fully educated about this proposal.

A presentation was given to the City Council on January 28, 2021 requesting the City to consider a Memorandum of Agreement, which was <u>Discussion Only</u> and no action was taken as to if the City would consider agreeing to the relocating 5 miles of rail track; talks are ongoing between the City's legal counsel and *rPlusHydro*.

The Mayor and City Council Members took an oath to serve the citizens and protect the assets of the City of Ely. The rail line is the only asset the City and Nevada Northern Railway has in the White Pine Pump Hydro Project proposal, but the total project could have a major impact on the citizens of the City

of Ely. Folks live in this area for the beauty of the mountains, valleys, ability to camp, hike, hunt, and fish right out our back door. The Mayor and City Council have a sworn duty to do what the people who elected them want them to do. **The public needs to be made aware of what is being proposed.** 

Regarding the draft environmental Visual and Aesthetic Resources Study, construction of the White Pine Pump Hydro Project will cause permanent damage to the natural beauty of the area. In regards to the Rare, Threatened, and Endangered Wildlife Species Assessment, destruction of Sage Grouse habitat in Duck Creek Basin will most likely start the end of Sage Grouse in Duck Creek Basin as we know it today. A thorough Recreation Resources Study will show how vital outdoor recreation activities – fishing, hunting, camping, hiking, OHV riding and cycling – are to our area's tourism industry and our local residents' quality of life, as well as the negative impact the White Pine Pump Hydro Project will have on these activities; the Nevada Northern Railway historical trains' tourist excursions must also be protected, as they are the community's number one tourist attraction. Eight Special-Status Plants could be negatively impacted by the White Pine Pump Hydro Project and potentially forty-seven Noxious Weeds proliferate more. Finally, the relocation of the track by the White Pine Pump Hydro project could negatively impact the Nevada Northern Railway as a cultural resource.

In closing, please become more transparent to our citizens, who are all stakeholders, and have Public Hearings for this project.
