FY23 CPF Process Update

- Senators Cortez Masto and Rosen have finally completed their FY23 Community Project Funding committee submission lists, below is a list of the three City of Ely FY23 CPF requests that both Senators chose to submit to the U.S. Senate Committee on Appropriations to be considered for inclusion in this year's spending bill:
 - Lower East Ely Water Mains Upgrade \$2,430,000
 - Water Meters Upgrade project \$4,083,000
 - Upgrade Central Ely Sewer System \$2,872,000
- Now all that's left is for the committee to pick which ones to include in this year's spending bill, and we'll know what they chose when the Senate marks up its spending bill drafts either later next month or in September when Congress returns from August recess.

Rural Air Service

 Porter Group has begun working with the Nevada League of Cities and Municipalities (the League) on identifying any and all federal opportunities to increase air service to Ely's Airport.

Federal Project Funding

- Porter Group continues to identify potential funding avenues for both established infrastructure investment priorities like the WBRH housing project and also for newer priorities like the senior care center project.
 - Pending further consultation with the City, Porter Group continues to identify grant opportunities for both projects in concert with the League and will continue to update the City on its activity in this area on recurring bi-weekly calls.

Nevada Northern Railway

- Porter Group expects the Department of Transportation to release a Notice of Funding
 Opportunity by the end of this month for the Department's newest rail-focused grant program,
 the Railroad Crossing Elimination Program.
 - This program has been identified by Porter Group as a suitable funding opportunity for at least one of the Railway's prioritized infrastructure investment projects and, following the program's release sometime this month, Porter Group will work with the Railway and the City to develop and submit an application for the program later in the year.
- Additionally, Porter Group has identified and is working to access railroad track improvement funding that may be available at the state level through the Nevada Department of Transportation that could also fund certain Railway infrastructure projects.
