State of the Street Department Mid-Year 2022-2023 Ending 1/31/2023

As the Liaison for the City of Ely Street Department I am providing this report to inform not only the Council and Mayor but also the citizens of our fine City the efforts being put forth to maintain and improve the 52 miles of streets in the City.

Budgeted revenue to fund the department are as follows:

Take note that Public Transit contributions cannot be used for labor expenses. Currently and in the past the RTC revenue is being used to fund special street projects for material, contractors, engineering, etc. As of this update no City employee wages have been expensed from the RTC revenue. Robinson Mine revenue is to help maintain the storm drains where the dewatering from the Robinson Mine flows through. County contribution is just that, money contributed by White Pine County Road Dept.

The Street Department has 3 employees with a budget for labor costs in the amount of \$276,634. Simple math will prove the gasoline fuel tax alone, will not cover labor costs for the 3 employees. The shortfall between gasoline tax collected (\$168,5960) and labor cost (\$276,634) is budgeted to be \$108,038. My projections are this shortfall will increase before year end.

The Street Dept. for the first 5 months, beginning July 2022 performed their duties as outlined in their budget. November started the winter season with the first snowstorm of size hitting the City on election day, giving the crew time to familiarize themselves with the streets when plowing. However, Mother Nature was getting ready to test their grit and determination by lining up a series of Atmospheric Rivers to hit our area with snow, rain followed by freezing temperatures along with more snow followed by a short warming trend with additional rain with more freezing temperatures. The 3-man crew performed outstanding, proving to Mother Nature that working long hours, being called out to work and being away from their families they can handle what she dishes out in order to keep the streets open for emergency services, home deliveries of on-line orders, postal services, trash pickup and the delivery of home heating fuels along with the streets plowed for the citizens.

Mother Nature blasted us on New Year's Eve with a snowstorm that hasn't been seen in our area probably for a decade. Deep snow along with blowing winds caused amazing drifts. The battle was set for our Road crew, and they took on the battle, giving up holidays and working long hours once again. The City Clerk reported, it was time to call for "All hands-on deck" to join the effort. Unfortunately, we

could only get 2 additional City employees with CDL's to join in. As most everyone witnessed, the effort was working, clearing, and hauling snow from the streets. But Mother Nature did it again and again, more snow and winds causing drifts throughout the City. A swarm of citizens helped attacking the problem with their plow mounted ATV's cleaning paths, sidewalks and driveways for the folks who were snowed in. This group were invaluable to the citizens after the snowplows passed, in helping clear blocked driveways, etc. Alley use was almost completely shut down and would have to be addressed later.

The crews quickly ran out of areas to haul the snow for disposal. City Hall and the Public Works Supervisor started receiving complaints about snow being dumped on empty private property lots, resulting with the crews having to haul the loaded snow outside the City to dump on areas NDOT approved for them to use. As usual, in a matter of time, there will always be folks that deem it ok to push snow from private properties back into the street that was clear of snow, causing hazards and extra work. In one incident, the individual was confronted about this practice by the Public Works Supervisor and things got heated. The situation was defused but it should have never got out of hand. This is a violation of a City Municipal code, to push snow into the City streets. Mother nature will have the last say after the snow is cleared and warmer weather arrives the streets will have plenty of potholes.

Back to the shortfall of gasoline tax verses labor costs. White Pine County pursued and were able to have the State collect and remit to the County .05 cents on every gallon of diesel fuel sold in the County and City. For F/Y years 2020-2021 and 2021-2022 there has been an average of \$375,000 per year collected from this diesel fuel tax, the current F/Y years is also expected to receive \$375,000. This revenue is being recorded into the RTC budget for use by both the County Road Dept. and City Street Dept. This fuel tax, like all gasoline taxes can be used for labor expenses as well as contracts for RTC projects. The unaudited diesel fuel tax fund balance as of January 31, 2023, is \$1,512,124 with additional revenue forthcoming.

As in past years, the General Fund transferred funds into the Road Fund to keep it fiscally responsible. As you can see in the one spread sheet I included, the amount being transferred is increasing yearly and I am projecting this transfer to exceed the budgeted amount of \$80,000. My estimate is closer to \$140,000. This being based on the snowstorms labor expense. The use of Landfill diesel fuel is also needed to be properly back charged to the Street Dept. What are the true costs to manage the Street Dept? In my opinion, it is not proper to use enterprise funds to subsidize the operations of other departments.

Diesel motor fuel is sold in the City of Ely, McGill and in the Baker area. Where are the most gallons pumped? Are there other ways to fund and support our Street Dept. other than transfers from the General Fund which take away from the operation of the City? Question is, can the City secure additional financial assistance to cover the shortfall between the gasoline tax and labor costs by using the \$.05 cents diesel fuel tax? This current year's snow event expense was not budgeted and there could be a possibility to have this unbudgeted expense receive additional funding. This funding request would not be reimbursable till F/Y end to ensure a more accurate dollar amount and hopefully it would carry on into future years.

"The use of Landfill diesel fuel is also needed to be properly charged back to the Street department. What are the true costs to manage the Street department? In my opinion, it is not proper to use enterprise funds to subsidize the operations of other departments."

Council Member Alworth received an email from City Clerk Lee on January 31, 2023 that addressed this issue that stated:

"City staff has a long history of addressing direct expenses such as payroll and fuel; I see it every two weeks when I sign time sheets and Leadman Sturgeon has been planning to purchase a load of diesel fuel for the Landfill out of his budget because equipment being used to clear snow has been gassing up at the Landfill for efficiency purposes. White Pine County's fuel card system is attached to specific vehicles, which belong to certain departments. Wear and tear have not been charged to the 'borrowing department' in the past, with the exception of abatements; Janette has researched this back to 2003. Mike coded the recent invoice for the Landfill dump truck (attached) to the landfill, reasoning that the truck would have broken down with the same amount of use at the Landfill. The twenty-plus-year precedent of an 'all hands-on deck' approach using employees and equipment from the enterprise funds to address large quantities of snow or other compelling needs to take care of our citizens is firmly in place"

The Steet and Landfill Lead persons planned ahead of time to repay the Landfill fund for the use of their diesel. Anytime employees outside of the Street department work in the street department, their time is recorded accordingly to the street fund. The accounting for the use of any of the Enterprise funds for other departments are being followed according to past practices.

The Nevada Northern Railway (NNRY) arrived in Ely Nevada on September 29, 1906 in support of the copper deposits in the area. The railroad was instrumental in the development of the copper mine, mill and smelter and supported their operations until they closed down in 1983. The copper mine reopened in 1995 and used the railroad from 1995 through 1999 when the mine closed once again. Since then, the mine has opened and closed multiple times. Currently the mine is open and going strong.

The City of Ely is applying for RAISE Grant funding for the replacement and enhancement of the NNRY rail line between the City of Ely and the Shafter connection to the transcontinental railroad in Elko County. Rehabilitating the railroad will once again connect the City of Ely with the international transportation infrastructure.

The NNRY has a long history of providing freight and passenger rail service to Northeastern Nevada. Prominent industries in the region include ranching, farming, and mining. In the past they have relied on the rail to move their products and bring in their supplies for over a century. The railroad has served as a lifeline for the community.

Unfortunately, in recent decades the entirety of the line has become outdated and obsolete forcing regional business to rely on trucking. The copper mine is completely dependent on trucking. Opening the railroad will lower the operating costs of the mine, making the mine more competitive in the global market place.

In addition to supporting the existing business in the area, the full potential of the NNRY rail line has simply not been reached. Rehabilitation and enhancement of the NNRY line between the City of Ely and the Shafter connection would strengthen and act as a catalyst for exponential growth in mining, agriculture and oil refining.

An active and modernized rail line between these two points would immediately connect northern and central Nevada allowing hay growers to export thousands of bales, hemp growers to transport tons of bio-mass, extend the life of the oil refinery in nearby railroad valley and allow mining companies to ship the equivalent of 26 semi-truck loads of copper concentrates each and every day by rail, while reducing overall fuel costs and CO2 emissions.

Opening the railroad will bring additional economic opportunity to the City of Ely and the area. Within the last five years, the Northeastern Nevada Regional Development Authority (NNRDA) has entertained a multitude of Requests For Information (RFI) from companies interested in relocating or expanding into Northeastern Nevada. Of those, nearly 20% indicated that their operations will require direct rail access.

Currently, there is not a single parcel available for sale in our four county region that has direct rail access. Should NNRY secure the RAISE grant, the opportunity for a siding and spur into the White Pine Industrial Park would immediately become an option that opens up nearly 200 acres for new and diversified economic growth within the community.

Due to this initiative's tremendous economic potential within Northeastern Nevada, the City of Ely strongly encourages that the Nevada Northern Railway be a recipient for 2023 RAISE Grant funding. Sincerely,

The extra manpower expense, (labor/benefits/overtime) from not only the 3 employees in the street department but also the other employees in the different departments is being recorded through payroll. The expense associated with the use of non-Street Fund equipment, fuel and breakdowns must be expensed to the Street Fund also. Former Landfill and Street Supervisor Rick Stork prepared a cost per hour document for using large equipment from the Landfill and Street Fund. If my memory is correct, I believe the document was approved by the UB and CC. My question is this, did the fuel for Landfill equipment and Water Fund equipment along with the hourly equipment charge get expensed correctly. Did the Finance department instruct the Public works supervisor to instruct the employees to use Street Fund codes when fueling equipment and to track equipment hours for non-Street Fund equipment for back billing purposes? Using Enterprise Funds (there are considered a business and should be used as such) should have been approved via the Council with approval on how to deal with associated expenses. Are rate payers paying for fuel and equipment wear and tear that should be a Street Fund expense? During the massive snow removal process there was Landfill dump trucks parked in front of a local repair shop, where were the repairs charged?

Citizens of the deserve better, the City staff need to get out the "easy way" paradigm and start thinking outside the box!

History on snowstorm assistance, WP County along with J & M assisted loading and hauling snow, then came their bill, ending that effort. The City did gain some knowledge from that effort and bought the snow blower, proving to be a game changer.


