On the February 9, 2023, agenda, the council approved to commit \$300,000 dollars of the Community Service monies to the Street fund to be used for up to two miles of street repairs.

Available Community Service expenses are budgeted in the General Fund. At this time, there is \$660,000 of Community Service monies budgeted to be transferred to the Sewer fund for the 20% match for the sewer improvement earmark grant. Due to there not being a need for the 20% match in this fiscal year, \$300,000 could be appropriated for a Street fund transfer. Once transferred to the Street fund, an augmentation would be needed to allow for the Street fund to start using these funds towards the council approved street repairs this fiscal year.

Any amount not expensed of the \$300,000 in this fiscal year would be available for the fiscal year 2024. If you have any questions, please contact me.
