#### 2. PUBLIC COMMENT

White Pine County Director of Tourism Kyle Horvath stated I'm not going to be here during the redevelopment talk, but I wanted to express my gratitude to the Board for the appointment to the Redevelopment Committee. We've had two meetings, and I just want to express my thanks to the board members as well as staff for the time and motivation that they've put into this. There is still quite a bit of work to do to get the incentive programs to where they're launched, but I'm confident with the group that we're moving in the right direction. Honestly, the impact that we all know this program can have is going to happen. So, I'm just looking forward to working with everybody and thanks again for the appointment to this really impactful position.

George Chachas stated on your agenda item 9B-6 regarding property rights at the freight depot and passenger depot and the preservation and ownership of historical documents, that needs to be denied. The Railroad Board needs to concentrate on running the Railroad Museum and not continuing litigation. The two council people sitting on the Railroad Management Board should not be voting on this issue at all as they cannot fairly represent the City's interest. When they have a clear conflict, they can't represent both sides. The Railroad Management Board has a poor record at best. They failed to collect fifteen years or more of track rental fees and cost the City as well as themselves a million or more in litigation, with no results and that needs to come to an end. Mr. Mayor, on your agenda, item 9B-7 addressing the hiring policy and procedure for exempt appointed officials; that policy has always been in place. You are the only one who's violated it and now you're attempting to make amends and cover your tracks. You have got to learn from the past mayor. Mr. Mayor, on your agenda item 7-3 through 7-9 you are to consider the approval to remove utility fee penalties for individuals. I'm not against them getting the write off, but I want equal consideration and protection under the law. I want to remind you that I paid for my property at 490 High Street, the principal and penalty amount as instructed in the letter received from City Clerk Jennifer Lee, dated November 25, 2019, and yet to date, the City is billing me for \$1,947.81. The City to date has failed to reimburse me for the overpayments that I made on the old Ely Grade School at 622 High Street. You wrote off all the back billing for young Tom Bath when he bought the Plaza Hotel at the same sale, that's discrimination. I remind you again, the City gave property owners of 790 Avenue I a \$4,000.00 or more write off when they used all the utilities. I think it was seven years they had not paid, and you claim the justification on an employee error. I want to remind you that federal law prohibits discrimination in any federally funded or assisted public utility and cannot selectively enforce the law. The City must be compliant with Federal law in particular, the age of Discrimination Act of 1975; the Americans with Disability Act of 1990; and the Civil Rights Act 1964, Title 6. I'd like some answers, Mayor.

#### 4. CITY DEPARTMENT REPORTS

#### > CITY FIRE CHIEF

City Fire Chief Stork stated just one quick thing to report. You've seen where we did fire inspections of all the commercial businesses. We did twenty-six different food establishments that serve food and out of those there's roughly twelve of them that had infractions, including my restaurant. Everybody was really receptive in getting things corrected and we've been going around doing the follow ups. However, there was one place that called me up, got pretty belligerent on the phone, and made threats they are going to get an attorney, and that it was my restaurant against hers. I stated that it wasn't, and at that point I turned everything over to the State Fire Marshal's office on this particular business. I Let them know this was a business that Craig and I had originally inspected, and they weren't cooking at that time. I didn't do the recent inspection, but when the guys did the inspection, they were in there cooking. I said, you have to have a type I hood, so that's kind of turned into a battle. I turned everything over to the Fire Marshals office on that to take us out of the loop. I wanted you guys to be informed that these inspections were done throughout the whole community in our response areas, and

this is an annual thing. After we had the incident with the last fire, we really want to try and get these done. They have got to be serviced twice a year. We inspected everything on fire suppression, fire extinguishers, and the grease cleaning of the hood systems. The rumor going around town now is that I shut them down because of competition with me, which is by far not the case. Like I said, I got wrote up also, and I had to make my corrections; I was not exempt.

We are also looking at a Grant program, possibly partnering with the tribe for installing another electric car charging station.

#### 10. PUBLIC COMMENT

George Chachas stated a couple of days ago your building inspector filmed in front of my store for almost a half hour. If there's a problem with my building, I need to know otherwise I don't want him around period. I was an inspector, and I didn't realize there was a problem as I wasn't notified and I don't know what games we're playing, but I'm not playing it. Mr. Chachas stated ongoing concerns regarding his request for reimbursement for the sewer problem he took care of at his property located at 681 Parker Avenue; the upgraded water line the City paid for on the property from Love's to the charter school and states that should have been the responsibility of the developer; his concern of the City paying to reroute a private sewer line during phase III of the Murry Street project; questioning RVs that have been permitted in the City and if they are paying utilities; rules and regulations being selectively enforced; the alleyway between his property and Napa having a problem for over a year, he is unable to get in there and do maintenance and wants that rectified; and the drainage from the Bath property onto his property at 622 High Street.
