2. PUBLIC COMMENT

City Clerk Lee read the following into the record:

May 23, 2024

To: Ely City Council and Mayor

From: Marty Westland

Re.: Letter of Commitment to provide \$19,547,905...

Dear Council and Mayor:

Regarding Item #7 under New Business at tonight's meeting:

I am astonished that the City's leaders would even consider the commitment of \$20 million dollars to restore rail service into Ely. I recall conversations with Glenn Terry as he recounted the last rail deliveries into Ely, and the difficulties of selling rail freight service to local merchants. Managers at the mine have explained the reasons they chose trucking. Jim Northness, who sat on the Railroad Enterprise Board for years, cautioned me that "the railroad" was the only endevour that could actually bankrupt the City.

Has anyone run a Cost-Benefit Analysis? Secured a contract for freight movement? Actually visited with railroad businessmen about the viability of a 120 mile spur running one or two trains per week? Shouldn't this project be part of an Enterprise Board? Can anyone tell the taxpayers of Ely how 20 million dollars will be recovered if rail service were available?

The most likely source of \$20 million dollars would be the State of Nevada. But just three months ago, you, the City of Ely and the Railroad Foundation, filed a lawsuit against the State. Claiming, among other things, that State employees are committing trespass by using Avenue "A". The relationship looks frosty.

Nevertheless, you are probably safe to sign a commitment letter. The chance of getting the grant is low. But if you ARE given a grant, then it looks like our community is on the hook for twenty million.

I would not accept that risk.

George Chachas stated I'm providing a map layout of the different lots that I own along Bell Avenue, which are serviced by the City waterline on Bell Avenue. The two water lines to lot one and lot two were accidentally taken out by the contractor when service was provided to the Washington Federal Bank and were never put back. Contrary to what the City Engineer has stated, I've never abandoned the two lines with those properties, and I want them back as shown on the map where they were originally at.



Mr. Chachas stated on your agenda item 9-B4 you're to consider approving a \$50,000 donation to the White Pine Public Museum to secure and transport various items; that item needs to be denied. The Museum is not a publicly owned entity; It is a private group. They want to put unpainted memorabilia that could possibly be seen as junk on the north entrance of Ely near the golf course. They need to start painting the display and securing doors on other items that could injure visitors. The city paid \$25,000 to consult with them on how to improve Ely's image yet we're going in the wrong direction. on your agenda items 9-6 and 9-7; both need to be denied. The Railroad needs to stand on its own two feet and pay their own expenses. They don't operate under the Nevada Open Meeting Law; they spend hundreds of thousands of taxpayers' dollars; yet the taxpayer is not allowed to see how the money is spent. The City Council has no right or obligation to commit to a \$20 million dollars project for the railroad. I remind you of the fiasco with S & S Short Line with no track rental monies collected for fifteen or more years. Council people that are directors on the Railroad have a conflict and need to abstain from voting.

> COUNCILWOMAN WILLIAMS-HARPER

Councilwoman Williams-Harper stated I would like to say thank you to Main Street. A couple of weeks ago the Mayor and I were invited to partner and attend an event in Birmingham, Alabama with other Main Street officials. It was extremely eye opening with all of the things that we can do if we work together as groups and come to a consensus on what will make our town even more wonderful than it already is. I was able to find out about several different projects that we can do and I've already started to put into some of those with the High School that would enhance our town. So again, thank you to Main Street, and you'll hear more later.

> MAYOR ROBERTSON

Mayor Robertson stated you have my report of permits. I'd also like to report that I attended the Great Basin Community College graduation this past week and was able to see four of our firefighters and a volunteer fire department personnel on the graduation list. We've been working very hard on some extra education, and it's great to see all the people that graduated; what a great program that is in our community. I'd also like to draw your attention to a letter I received from the Mayor of West Wendover, who'd received some help from our Animal Control Officer, Andrew Hayes. They worked together on a feral cat trap, neuter, and release (TNR) event, and they were really appreciative of Andrew's help, and found him to be very pleasant to work with. They let us know that anytime we needed the favor returned, they'd be happy to do that.

B. NEW BUSINESS

1. Mayor Robertson – Legacy Racing Race Director Donald Jackson – Discussion Only – Presentation on Legacy Racing's local race at the end of June 2024.

Legacy Racing Race Director Donald Jackson stated we're doing an off-road race from Mesquite to Ely June 28th, and then on the 29th, we're going to go Ely to Ely. It's a race for cars, trucks, bikes, quads, and UTVs. We've been working on it for over a year now with the BLM and Forest Service on our permitting process. We Just wanted to make sure that city officials were aware of the event. We announced the locations in January of this year and within three days we sold out all the hotel rooms so it's going to be a fairly large event. We expect probably a hundred participants of race vehicles, and probably three hundred chase vehicles chasing them up and down the highway. We've talked to the Sheriff about the event, and so he's aware of it as well.

Mayor Robertson asked are you planning on making this an annual event?

Legacy Racing Race Director Donald Jackson stated we would love to, but we're going to see how it goes this first year. There's lots of puzzle pieces that we're finding may not work to everybody's benefit. Right now, we're dealing with sage grouse, which is all the way through June 30th. They want us to go later in the year, but then you get into the hunting season and if we do it earlier in the year, then you get into calving season. We also work with the road department and don't want the roads to be muddy or whatnot. There's a fine line of when we can put the event on, but we're going to get through this first one and then look to see what it looks like for future events. We also hope to reserve Broadbent Park because we're going to try and display the race vehicles on Friday night, that way the public can come see them, and interact with the racers too.



3. Councilwoman Williams-Harper – White Pine Main Street Chairwoman Caroline McIntosh – Discussion Only – Report on White Pine Main Street's community activities.

Councilwoman Williams-Harper stated it was wonderful to spend time with the people that we went with. The thing that I went to that meant the most to me was titled "Y'all Means All," remember, we were in Birmingham. Simply said is, there is a place for every organization in our town to get together with other organizations and find out what it is we can contribute, or what we do best. There were a lot of eye-opening things I hope to take back to the places and people that I'm involved with. I'm ready to hit the ground running.

Mayor Robertson stated I'll also add it's always a great conference. There are more classes than anyone could possibly attend and any conference attendee with any question about any aspect of the Mainstreet Program, or with certain issues that are going on in their community, can find a class or twelve to attend on any particular issue or concern. I attended classes on historic funding preservation; driving economic vitality, which is one of their pillars; workforce housing, kind of the importance of having a geographic definition about your main street and community outreach; and one of the things I think our community does really well already is the outreach. We have so many organizations like SBDC, SBC, RNDC, the banks, and the Chamber is so invested in making sure our businesses are successful that they get a lot of one-on-one attention, and I think that's a real strength in our community. When they were going through some of these things in this class that they do, I'm thinking, we do that, and we are really good at that already. We have some skills that are already serving us but have such a lot of potential for growth. One of the most interesting classes I went to was a class on workforce housing in Hugo, Colorado, which is out on the plains on the east side of the State. She started off by saying their town was four blocks wide by six blocks long, and she was their main street coordinator. They had a lot of housing issues similar to ours. They were near a state prison, they had teachers and other essential workers who needed housing, but rent was really high, and a lot of people were sitting on houses because it was so cheap to sit on houses that they wouldn't sell them, rent them, or fix them up. One thing I heard a lot in a couple of different classes was about the vacancy tax and I think we've talked about that here before. Where, if you're not selling, improving, or occupying your property instead of holding it hostage, you might get an extra fee on your property taxes to incentivize you to go do something else with it. A lot of the community outreach revolved around how interactive art, street murals, nice curbs and gutters, trees, somewhere to sit and things people can interact with would draw people downtown or to an area, because it's a nice place to be. They want to interact with some art, and they want Instagram pictures. I think we all attended some classes that involved some of those street murals that slow people down as they drive by cause they're looking at it, and it really drove home kind of the opportunity that we have here for this NDOT project that's going on downtown, where they're going to be doing a lot of these things that are going to be traffic calming and that's something that drives economic vitality quite a bit. Another interesting class I went to was on the importance of having a geographically defined area for your downtown Mainstreet Program. It was given by people from the District of Columbia, where they have 28 different Mainstreet Programs just in the District of Columbia, because D.C. doesn't really have a downtown, t's got kind of different neighborhoods. Rather than have one main street program for the whole District of Columbia, they kind of focused on one, got it going, and then used that to leapfrog to other communities or neighborhoods in the D.C. area. I think that's most of the highlights, but with the opportunities that are coming down the pike I'd really like to see Main Street kind of focus on the downtown with this NDOT project and get everything firing on all cylinders so we can take this program elsewhere. It really does have the potential to be able to use the strengths of our other organizations and businesses, and what the State has to offer to make it work in a small geographic area in downtown.

RE: Consolidated Rail Infrastructure and Safety Improvements ("CRISI") program grant application for the Nevada Northern Railway Track Rehabilitation for Freight Traffic.

The purpose of the grant is to rehabilitate the railroad from Shafter, Nevada (MP 18.5) to Hilling Junction, Nevada (MP 135.4), covering a total distance of 116.9 miles of railroad track. This section of the railroad predominantly consists of the original 60-pound rail from its construction in 1905/1906, whereas modern standard rail typically ranges from 130-pound to 141-pound rail. Fortunately, Kennecott previously upgraded the railroad from HiLine Junction to Ruth with 90-pound and 115-pound rail, which can accommodate modern freight traffic. Additionally, the Foundation conducted a tie replacement program from HiLine Junction to Ruth, resulting in this section of the railroad being in relatively good condition.

FMW and the Foundation have conducted a comprehensive inspection of the entire railroad from Shafter to Ruth. Furthermore, FMW has updated previous engineering studies related to the railroad. Based on these assessments, the estimated cost to open the railroad to freight traffic is \$129.7M, with the grant request set at \$94.0M. We have secured a commitment of an estimated \$15,225,997 in ballast that can be used as match, leaving a remaining cash match of \$19,547,905. The cash match will not be required until October 2025 and only of the grant is

On the agenda is a Letter of Commitment to be signed by the Mayor in support of our mutual grant application. As I mentioned at the last City Council meeting, there are multiple avenues to pursue for raising the \$19.5M cash match including seeking support from the Nevada State Legislature, approaching the Nevada State Infrastructure Bank, and exploring federal options such as the Transportation Infrastructure Finance and Innovation Act (TIFIA) and the Railroad Rehabilitation & Improvement Financing (RRIF) loan.

If a loan is required, the financial plan indicates a minimum of 8,000 car loads a year, growing to over 12,000 c loads annually. The revenue generated from those car loads will cover the cost of a RRIF loan. The applicant for the RRIF could be the City of Ely, the Foundation or the Foundation's wholly owned freight railroad the Great Basin and Northern Railroad.

During the interim period, while awaiting the grant determination, FMW and the Foundation will collaborate on assembling a funding package for the cash match. This package will comprise of multiple components, in other words, our goal would be to find enough funding without the need for the a RRIF loan. But If a RRIF loan is needed, the particulars of the loan are unknown at this time, We have a year to make that determination, after the grant awarded, if it is awarded

Downtown Ely Visitor Center Plan

OVERVIEW:

- Local visitor's centers are co-located within local chambers of commerce in most communities in the State of Nevada and across the United States.
- These visitor's centers are funded by transient lodging tax, not the local chambers of Commerce
- The high traffic, main street visibility, and the long-established tendency for visitors to stop at the WP Chamber of Commerce for local information was the reason an official visitor center was established at the Chamber office about 5 years ago.
- Sincer the withdrawal of support of that visitor center in December of last year, the WP Chamber
 of Commerce has continued to operating a visitor center as staffing and funding has allowed. This
 has included partnering with AARP to provide funding for wages for a part time employee to staff
 said visitor center.
- WP Chamber of Commerce is seeking funding from the City of Ely to be able to hire additional people specifically to staff the visitor center. The goal being to eventually secure enough funding to enable the visitor center return to being open and available to the traveling public 7 days a week
- The funding being requested will not be used for the operation of the WP Chamber of Commerce or to pay the salary of any Chamber executive. Funding will only be used to pay for staff to operate a visitor center.
- Whether or not a supported visitor center is located at the WP Chamber of Commerce, visitors to
 our community will continue to stop at the Chamber for local information. Funding support staff to
 interface with out of area visitors allows the Chamber to continue its primary mission of supporting
 the member businesses contributing to the city and county's enhanced quality of life.

- Compile and supply a monthly Visitation report detailing origin of visitor, reason for visit or ultimate destination as well as number of visitors for an approximate estimate of out-of-area traffic.
- Maintain public sidewalk informational boards with up-to-date promotional materials.

10. Council Members – City Clerk Lee – Discussion/For Possible Action – Approval to commit \$600,000.00 of Community Service Funds to Wastewater Treatment Plant CPF Upgrade Project.

City Clerk Lee stated as outlined in your backup documentation, in March of this year the EPA changed its cost share waiver criteria. Unfortunately, now the City doesn't qualify for any of the five points. For the other two projects we qualified for two. Thankfully we got those cost share waivers back in August, because that criterion was retroactive to those project years; so, we're grateful for that. Outlined in number one it explains that our cost share for the Wastewater Treatment project is \$1.2 million and if we commit 600,000 of that money that was set aside for Central Ely, that will just leave us \$603,750.00 and we received over that for our last CDBG ask. In the next round of CDBG grants that grant money is eligible to use with these. That's my recommendation that prevents us from having to borrow money to get that important Wastewater Treatment Plant Project done.

Councilman Carson moved to approve committing \$600,000.00 of Community Service Funds to Wastewater Treatment Plant CPF Upgrade Project. Councilman Trask seconded the motion. The motion carried unanimously.

11. Council Members - City Fire Chief Stork - Discussion/For Possible Action - Approval to order one (1) Rosenbauer Pumper Truck, complete with Rosenbauer Commander Chassis per specifications with funding from the following sources: City of Ely \$250,000, White Pine County \$200,000, Ely Volunteer Fire Department \$10,000, William B. Ririe Hospital \$10,000, and the Pennington Foundation \$457,508.

Councilwoman Elliott moved to approve ordering one (1) Rosenbauer Pumper Truck, complete with Rosenbauer Commander Chassis per specifications with funding from the following sources: City of Ely \$250,000, White Pine County \$200,000, Ely Volunteer Fire Department \$10,000, William B. Ririe Hospital \$10,000, and the Pennington Foundation \$457,508. Councilwoman Williams-Harper seconded the motion. The motion carried unanimously.

12. Council Members – City Fire Chief Stork – Discussion/For Possible Action - Approval of recommendation to suspend open burning in City of Ely limits May 27, 2024, through October 15, 2024; this proposed action would not affect previously approved Open Burning permits.

City Fire Chief Stork stated this is something we do every year. The weather this next week is going to start warming up and open burning becomes more of a nuisance for people than it does a big safety hazard in the City for us. We get flooded with complaints and with the people closer to the hillside it does present a hazard.

Mayor Robertson asked this does not affect if someone has a backyard fire pit?

City Fire Chief Stork stated no, those are perfectly fine to have.

Councilman Carson moved to approve suspending open burning in City of Ely limits May 27, 2024, through October 15, 2024; this proposed action would not affect previously approved Open Burning permits. Councilman Trask seconded the motion. The motion carried unanimously.

13. Council Members – City Fire Chief Stork – Discussion/For Possible Action – Approval to transfer 1922 Fire engine from the City of Ely to the Ely Volunteer Fire Department.

City Fire Chief Stork stated the Volunteers have had the 1922 GMC in their possession for fifty years that I know of. We finally found the title and this truck was still listed in the City's name. The 1928 has been signed over to the Volunteers, and the Volunteers are the ones who basically keep all the history for the Fire Department. I would like to see that truck signed over to them officially to where they can keep it along with the history.

Mayor Robertson stated my understanding was that was the intention years ago.

Councilman Carson moved to transfer the 1922 Fire engine from the City of Ely to the Ely Volunteer Fire Department. Councilwoman Williams-Harper seconded the motion. The motion carried unanimously.

10. PUBLIC COMMENT

George Chachas stated you folks talk about a housing shortage, but I've applied for permits and I'm refused. I don't want to hear you saying that you're going to force someone into selling their property by increasing their tax. I want to use my properties as others do, but I'm not allowed to. Councilwoman Elliott did a good job on Nevada Avenue. The complaint came in on the nineteenth and when I went by the morning of the twentieth it was patched. I want to know what kind of problem you've got with ethnic minorities and Vietnam veterans. We deserve the same consideration. Mr. Chachas stated ongoing concerns regarding the drainage issue behind NAPA near his property preventing him from getting in to do maintenance; The egress and ingress at Golden Gate Convenience Store; code violations not being addressed by the Regional Planning Commission, City Council or County Commission; those that have been permitted in the City to park RVs and if they are paying utilities; the drainage from the Bath property; and reimbursement for the sewer problem he took care of at his property located at 681 Parker Avenue.

11. ADJOURNMENT: THE MEETING MAY BE ADJOURNED BY APPROPRIATE MOTION OF THE CITY COUNCIL

Councilman Trask moved to adjourn the regular meeting of the Ely City Council at **6:08 p.m.** Councilwoman Elliott seconded the motion. The motion carried unanimously.
