2. PUBLIC COMMENT

George Chachas stated on your agenda item 8-1 and 2; if the City Council approves those items, as did the Utility Board, then the same consideration must be given to others that have the same type of situation in the past. The Utility Board and City Council did not treat everyone the same on your agenda item 9-1. You are to consider City Attorney Chris Arabia's employment arrangements and possible salary increase. Again, I have nothing against Mr. Arabia. He receives \$140,000 now, the White Pine County District Attorney receives \$123,000, and has considerably more responsibilities. The City needs to live within its means. You people are giving out raises that can't be sustained without raising fees and taxes. Raises should not be more than 3% to 10% at best. Local businesses and residents have not seen, nor did they receive raises of 40% or more; shame on all of you. I can't get a simple permit for which I'm willing to pay to stay in my business, but I'm forced to witness this philandering of public money. You people have no business in government. On your agenda item 9B-2 regarding Ordinance 763, dealing with prostitution, why was this item not brought before the Regional Planning Commission for review? On your agenda item 9B-6 regarding the possible acceptance of the CDBG award for the 7th Street Drainage Improvement Project there's nothing provided for sidewalk installation and that area qualifies for consideration as there's low income and many minorities. You need to address the buildup of sage brush posing a fire hazard. In that area we want sidewalks included, as you have with others, no discrimination. On your agenda item under reports on item four since when did the City Clerk start charging \$12 to \$15 for a business license; I paid over \$126. You need to review what your people are doing.

8. ITEMS FOR DISCUSSION/POSSIBLE ACTION OF THE ELY CITY COUNCIL AS RECOMMENDED BY THE MUNICIPAL UTILITIES BOARD.

1. Board Members – City Engineer Almberg – Discussion/For Possible Action – Approval of Kelly Barney's Will Serve Application for one sewer connection at 940 Avenue C.

Mayor Robertson stated these four structures at one time, many months ago were one parcel. They built the first building on the corner, and then there were three foundations sitting there unused for a number of years. I think they eventually sold those three off, and built structures, but the utility had already been put in. The utilities never got separated and so currently, there is one sewer service going through the two properties and four buildings. This is approval to correct that and the cost to correct that is being borne by the property owner.

Councilman Perea asked, "Is this something that should have been caught by the City?"

Mayor Robertson stated yes, this is something that probably should have been caught by the City. It's something they probably should have been required to do when they sold part of the property off, but that certainly predates anybody on this Council or in the Administration, and so I don't know who to point a finger at.

Councilman Trask moved to approve of Kelly Barney's Will Serve Application for one sewer connection at 940 Avenue C. Councilwoman Van Camp seconded the motion. The motion carried unanimously.

2. Councilwoman Van Camp – City Engineer Almberg – Discussion/For Possible Action – Approval to waive Will Serve fee up to the amount of \$2,975.00 from 940 Avenue C, Ely, Nevada at the request of Property Owner, Kelly Barney due to a joined sewer service that was recently discovered and that predates current ownership of the property.

Mayor Robertson stated this was also approved by the Utility board. Again, the owner is taking care of the cost to do the work and they are just asking for a waiver of the connection fee.

Councilwoman Van Camp moved to approve waiving the Will Serve fee up to the amount of \$2,975.00 from 940 Avenue C, Ely, Nevada at the request of Property Owner, Kelly Barney due to a joined sewer service that was recently discovered and that predates current ownership of the property. Councilman Perea seconded the motion. The motion carried unanimously.

B. NEW BUSINESS

1. Mayor Robertson – Discussion/For Possible Action – Review and determination regarding City Attorney Chris Arabia's employment arrangements, including but not limited to Ely Municipal Code (EMC) 1-6-6-3 and 1-6-6-5 and possible salary increase.

City Attorney Arabia stated first of all, I want to say that I've been in this position for six months now, and I'm really happy to be here. I've enjoyed working with all of you. I think the City is well governed, I like being a part of that, and I think that I've done a good job. What I'm here to ask for today is actually something a little different than what I was expecting. I would like to ask that you give me an extension for the next six months from the residency requirement. I have some personal situations that preclude me doing anything in that direction at the present time, and I don't know if or when that's going to change. I would like to stay involved here and continue the work that I'm doing. It says here about a possible salary increase and I'm not asking for a salary increase at this point. I don't think considering what I'm asking you, that it would be appropriate for me to also ask for more money. That's what I'm hoping to do, and we can revisit this a few months out. I know it's not ideal, but this is a case, I think, of not letting the perfect be the enemy of the good. So, I'm hoping you'll agree to that. Thank you.

Mayor Robertson asked, "Could you discuss a little bit about the schedule you're proposing for being here and being remote?"

City Attorney Arabia stated I think, as you guys have seen over the past six months, I consider it very important to be at City Council meetings; I haven't missed one. On the criminal side the only thing that absolutely requires me to be present in person is trials, and I'm more than happy to do that. We've only had two so far. The Municipal Court is aware of this, and they have agreed, and I think Judge Hibbs, I don't want to speak out of turn, would be happy to have me staying. It would be kind of an as needed thing, but those would be the bedrocks. I plan to be here for all the City Council meetings.

Mayor Robertson stated I'd like to say City Attorney Arabia has always been available. He's present either in person or on the phone for any meeting that's scheduled. He's accessible to the staff and never had a problem getting responses or getting the work done. I had him do some research between the Ely Municipal Code and NRS prior to this and there are some corrections we're going to need to make in our Ely Municipal Code, as it does require city officials to live within White Pine County, however, NRS specifically prohibits cities from making that requirement for a city attorney position. There was an oversight there that needs to be corrected so there's nothing wrong in allowing this working arrangement, legally speaking.

Councilman Trask stated I just want to make sure of the availability, which hasn't ever been an issue, but making sure it's still first priority.

City Attorney Arabia stated I think that's the one thing that I can offer is that this is my number one priority I have right now. I have one case in Pahrump, which is a family law case, I'm doing pro bono for altruistic reasons. I'm not going to take anything on that would push this to number two, which means that you will always be able to get me, and I try to get the work done in connection with this as soon as possible. So, that's not going to change.

Councilwoman Williams-Harper moved to extend City Attorney Arabia's probationary period by six months for review and possible salary increase and in the interim to update the Ely Municipal Code to match Nevada Revised Statutes regarding residency requirements for the City Attorney position. Councilwoman Van Camp seconded the motion. The motion carried unanimously.

Subject: Security Cameras RFP Consultant Selection Procedures

Key Considerations:

- 1. Submitted Proposals were evaluated independently by each member of the technical review committee consisting of Mayor Robertson, Public Works Director Cracraft, City Treasurer Trask, White Pine County Sheriff Henriod, and White Pine County IT Director Jasen Hutchens— on Project Fee Breakdown; Past Performance; Equipment Quality and Capability; Project Approach; and Availability and Capacity. Ford AV and Pavlon Connect and Protect scored within 6.2 points of each other, triggering City Council interviews for all firms within 10 points of the averaged winning score.
- 2. Final selection by the City Council will be based <u>solely</u> on the average of the interview scores.
- 3. Interview questions were developed by the technical review team members, in consultation with the City Attorney. The same questions will be asked of each proposer, and no additional questions may be asked of any proposer. Each firm will provide a brief presentation and answer identical questions; Council Members' scoring will be averaged immediately afterward, and the Governing Body will select the winner as part of this agenda item.

City Attorney Arabia stated just to summarize what's going to happen, each of you should have the matrix in front of you indicating there is going to be a presentation, which we'd ask you to keep under ten minutes, and can be scored up to 12.5 points. There are seven questions which you should have received previously, each of which can also have a

score of up to 12.5 points. The counselors will listen to your answers, assess them and mark their scores. City Treasurer Trask will collect and tally the results, and that will give us our result. I would like to add that this procedure is certainly consistent with any applicable laws.

City Clerk Lee stated we will need the Pavion representatives to leave the room virtually while Ford AV is being interviewed and once that interview is complete, we will readmit you.

Ford AV Interview:

Ford AV CEO Jim Ford stated Ford Audio/Video is located in Oklahoma City and we have Vic Wenner, who is the Division Manager in our Salt Lake City office. That is a full-service office, and you're closest to our Salt Lake City office, even though our Las Vegas office is also kind of close. Daniel Nguyen is the Account Manager from Las Vegas, and he came to the site survey. We have two experts on the line; one is Phillip Pappadakas, who is our corporate service manager. He is an Avigilon expert and trained fully in how to implement large Avigilon systems like South Black in Dallas. Designer Thomas Williams has a long history of that too. I have a short presentation I would like to share with all of you.

Ford AV CEO Jim Ford reviewed the following presentation:

Mayor Robertson asked the following interview questions:

1. Please explain in detail a similar project that you worked on and how the project turned out.

Ford AV Corporate Service Manager Phillip Pappadakes stated the City of Southlake is a city here in the Dallas Fort Worth Metroplex where I'm located, which has installations across the City of more than 250 Avigilon cameras, located across more than a dozen sites with wireless backhaul as well as hardwired CAT connections for its camera and local video recorders in much the same that we're proposing. We continue to work with that customer, and we've been managing and expanding that system for more than five years now. We continue a turnkey solution provided to the customer in the city in each and every installation that we do for that and that includes all of the networking backbone, bringing the cameras onto the NVR system, training for any operators on how to actually interact with the system, as well as preventative maintenance in the period of the warranty on the actual equipment and the cameras.

2. What type of challenges do you see in completing this project and how will you overcome them?

Ford AV CEO Jim Ford stated we send out seventy crews a week, and we're always in construction. I don't believe we'll face any supply chain issues. Avigilon is up to date, and we're a big user of Avigilon. Networking is pretty straightforward, and installation of the cameras is straightforward. Probably the biggest obstacle is, where do the cameras go? How do we mount them? Can we mount them safely and get connectivity from that camera? If we're up on poles, we'll be using the ubiquity wireless. So, I would say, it's standard construction issues, but this is what we do every day. So, in general, I really don't see very many problems other than picking the places and getting it installed up on buildings and poles.

Ford AV Corporate Service Manager Phillip Pappadakes stated I will add there are two main factors in the performance and installation of the system that would be outside the direct scope of our proposal that we would do the actual coordination for and that's primarily electrical. So, bringing high voltage to things like the various light poles, Ford AV is not a high voltage vendor, so we would be coordinating with the electrician. Their actual performance is something that is technically outside of Ford's scope, but still relevant to the performance as well as coordination with and performance of the City's network that actually brings the end user, the operator, to the Ford provided server that houses the actual video. That connection won't be directly built by Ford AV, but it's still relevant to the performance and so we'll want to make sure during that coordination that it's set up correctly. Those are the two main considerations I would have that are potential pain points just because they're outside of Ford's control. As Mr. Ford said we have a lot

of experience with this and I don't have any concerns about our ability to perform, but just the nature of coordination on the construction side of things would be the only point to bring up.

Mayor Robertson asked, "just to be clear, the power supply to these facilities is not part of your proposal?"

Ford AV Corporate Service Manager Phillip Pappadakes stated in all instances where we're bringing a camera directly to an actual location via hardwired cabling we would be providing power. Primarily what I'm talking about is the instances where cameras are on, say, a light pole. That light pole has high voltage that an electrician would then connect to our equipment in order to power our equipment, since we can't plug it into an outlet in the same way you would in an electrical closet for the interior cameras on buildings.

3. How will you meet the client's expectations of the project?

Ford AV CEO Jim Ford stated that's what we do every day. If you notice some of those clients I mentioned like AT & T, Nationwide, and we're doing the U.S. House chamber. We were just awarded that in Washington, DC, so we're going to be redoing that whole house chamber, and we've been doing that for twenty years, and you can't do that unless you keep your promises. Our business is to execute the installation on time, meeting the milestones, delivering quality, and meeting the specifications; that's what we do in all jobs. We're one company, we are not siloed, so all of our technicians are all trained the same way and with the same installation practices. We deliver quality on time, and we keep our promises. We are going to be very customer friendly. We work with our customers very closely, that's how we keep them.

4. How would the Sheriff's office access the cameras?

Ford AV Corporate Service Manager Phillip Pappadakes stated our system again, as I mentioned, is turnkey. So, we would have the server brought onto the City's network and coordinate with the City's IT team to get access from the Sheriff's office to those servers via a software package that's called the Individual on Unity Video Client. Essentially in layman's terms, what that means is the Sheriff's office would open their computer, launch the software, log into the server, and pull up the cameras that they want to see.

5. What license plate reader capabilities does the proposed system have?

Ford AV CEO Jim Ford stated we operate about 250 Avigilon cameras through our location here in Oklahoma City, and we have a license tag camera reader on our main entryway.

Ford AV Designer Thomas Williams stated the license plate reader camera actually incorporates two lenses; one that is dedicated for a lane to capture the license plate, and then a second lens that is more of a wide view to see what the vehicle looks like and things of that nature. The City parks are incorporating license plate reading cameras around the periphery. Your City Hall, for example, has two pointed at the two points of entry. Some facilities did not have high traffic areas. There was one park in particular that didn't have parking that was very close, so we did not incorporate a license plate reading camera at that facility, while we do have other cameras dedicated to having a full view of the activity involved. The license plate reading camera itself is a very specific unit of hardware and would not be recommended for every camera installation. Avigilon, the brand that we are proposing, actually has one of the widest selections of cameras available. So, we are fine tuning the proposal to give you the right camera for the right location, the right tool for the right job.

6. There is a large difference between the two proposals regarding pricing. Please break down your materials and labor costs, explaining the ways your pricing proposal benefits the City of Ely and the White Pine County Sheriff's Office.

Ford AV CEO Jim Ford stated the labor is about \$192,000. We have travel expenses because it's quite a ways to get there, some car rentals, and things like that, which is

\$113,000. If you add those up, they total approximately \$306,000. The materials which we're also carrying 2% for freight above the cost of the materials or the equipment and we're carrying a 2% contingency, which is pretty normal. If you add all that up it comes to \$538,000. We do carry overhead and profit, which is about 10% overhead and 5% profit. Anyway, that all comes up to \$844,000. It is 2,958 hours of labor and that is all types of labor including engineering, fabrication, job superintendents, project managers and so forth.

7. After selection, are you willing to amend your proposal to better accommodate the City's TEP grant requirements?

Ford AV CEO Jim Ford stated the answer is yes, we are very flexible, and we will work with you.


City Clerk Lee stated if the Ford team could leave the meeting during Pavion's interview, and then we'll let you back in for the final section of the agenda item.

Pavion Connect and Protect Interview:

Pavion Connect and Protect Account Executive Hyong Cho stated good evening members of the Council, my name is Hyong Cho with Pavion and I'm the Account Executive who responded to the City's request for the security camera system integration proposal. With me is a gentleman named Hudson Sherr and he's here to answer any technical questions regarding the system that we're proposing. The Request for Proposal (RFP) was to provide a professional installation service for the security camera system for the City of the Ely facilities and public parks and our objective was to deliver a robust, scalable security camera system easy to manage, and also to maintain.


Pavion Connect and Protect Account Executive Hyong Cho reviewed the following presentation:





















Pavion Connect and Protect Account Executive Hyong Cho stated here are some of the sites we visited and the coverage areas. The coverage areas in yellow show the video coverage and the purple represent the license plate recognition (LPR) cameras. Most of the sites do not have any internet or access to the internet or a web connection so, we are going to put in wireless cell routers.













1. Please explain in detail a similar project that you worked on and how the project turned out.

Pavion Connect and Protect Account Executive Hyong Cho stated one of the projects we have done is with the State of Nevada. The State of Nevada Department of Transportation had a lot of on Premises cameras, about 400 of them, and they were constantly driving around updating all the firmware whenever Microsoft came up with the security patches for cyber threats. They had to do all the updates, and they wanted something they would have minimal maintenance on. So, we did an upgrade of 410 cameras for the State of Nevada Department of Transportation across the State and that turned out really good, and I did reference that and provided a contact name as a reference on the proposal.

Councilman Perea asked on those projects it sounds like it was all back end, did you do any onsite installation on those projects.

Pavion Connect and Protect Account Executive Hyong Cho stated not for the NDOT project but for the University of Nevada Reno we do all their installs. The original installation for NDOT was performed by us and then the customer wanted to have something different because of the IT resources. We're having similar issues with the VA Hospital as their IT resources have been downsized dramatically, so a lot of the servers are not being patched or are not being kept up and those are the reasons they are wanting to do a cloud solution.

2. What type of challenges do you see in completing this project and how will you overcome them?

Pavion Connect and Protect Account Executive Hyong Cho stated it's definitely going to be the distance and the remoteness of the project sites, but we have done similar projects at the Robinson Summit. We did a project out at Robinson Summit for the NV Energy switchyard, I believe it was a 350 and 450 kb switchyard out there and was about a five-month project. We had our guys travel and stay at a hotel. We completed that project on time and we are still maintaining that site and assisting them with the day-to-day operations.

3. How will you meet the client's expectations of the project?

Pavion Connect and Protect Account Executive Hyong Cho stated again, my biggest concern was the lack of data connection or internet connection to each of these sites and that's prohibited us proposing the on-premises solution. A lot of the sites are challenging because there is not a clean environment for us to install network video recorders and switches because these were open wells and pump stations that are not environmentally controlled. We decided to go with the on-cloud version, because the cameras are hardened and that they have a ten-year warranty. We are proposing a 5G industrial rate of 5G routers, everything will be sent up to the cloud, and then all the information will be residing there. Each camera has an SD Card that can store all the videos as well so there will be minimal equipment at the site.

Mayor Robertson asked, "Is it a problem if there isn't 5G service in the area where the cameras are installed?"

Pavion Connect and Protect Account Executive Hyong Cho stated that when I visited all the sites, I had really good cell coverage at every site. I had T- Mobile and at some of the locations I was pushing 300 to 400 megabits per second.

4. How would the Sheriff's office access the cameras?

Pavion Connect and Protect Account Executive Hyong Cho stated So this being born on the cloud we can have a workstation set up at the Sheriff's office, and if the Sheriff or the other officers patrolling the areas have an iPad or some kind of mobile device they can connect to the cloud directly; because everything is in the cloud, they can access it through the cloud.

Mayor Robertson asked, "Does it require a certain app on those programs to do that or is it all web-based?"

Pavion Connect and Protect Account Executive Hyong Cho stated it's all web based. They support Internet Explorer, and I think they support just about every browser that's out there.

5. What license plate reader capabilities does the proposed system have?

Hudson Sherr stated with the ALTA solution, the cameras that are proposed for the project and enabling that LPR license you will have the ability to capture any type of vehicle that pulls up within view of that camera. So, you can also do analytic searches based on a full license plate match, you could do a "starts with" license plate if it maybe only got the beginning, "ends with", "contains", and all kinds of other types of mixtures that you wanted to do. You can have those to be able to go back and search for an incident. You can also create a "hot list", as you may call it, or a "be on the lookout for" list. If you have known aggressors or people who are trespassing in areas, you can set up these license plate groups to be alerted to your system anytime that license plate to that vehicle is detected. Once that's detected it will send an alert either through the mobile app or through the Google Chrome browser when you guys are running the software or to your email. The LPR capabilities will let you know what is going on.

Pavion Connect and Protect Account Executive Hyong Cho stated if the Sheriff's office is using Motorola radios we can push the alerts through the radios as well.

Councilman Perea asked, "will you be able to read license plates at all the locations proposed in the proposal.

Pavion Connect and Protect Account Executive Hyong Cho stated there are a total of nine LPR camera licenses proposed on this project and because some of the sites were very remote, working from the hills and whatnot, those would not have LPR capability. The parks and the some of the City areas will have LPR capability.

6. There is a large difference between the two proposals on pricing. Please break down your materials and labor costs, explaining the ways your pricing proposal benefits the City of Ely and the White Pine County Sheriff's Office.

Pavion Connect and Protect Account Executive Hyong Cho stated yes, we do a lot of work with the VA hospital, and we understand the federal grant process. We are more than happy to comply and meet the requirements of the Federal FTA forms.

Mayor Robertson recessed the Regular Meeting of the City Council at 6:06 p.m. so the City Treasurer can average the scores and then we will reconvene to hear the results.

Councilman Trask moved to select Pavion Connect and Protect for United States
Department of Justice Federally Funded Project No: 15JCOPS-24-GG-02256-TECP
Security Cameras Installation Project, based solely on the average of the interview score.
Councilwoman Van Camp seconded the motion. The motion carried unanimously.

7. Council Members – City Attorney Arabia – City Building Official Hendrickson – Discussion/For Possible Action – Approval to grant an extension through July 24, 2025 to Sam L. Bida to demolish the condemned structure per condemnation order dated April 15, 2024.

Building Official Hendrickson stated this was brought forward a little while ago proposed by Levi Garcia and I sent Levi to the City Attorney for clarification. The recommendation was, if we gave them another chance, they would have everything lined up having a contractor with proposals, and everything to get this done in a timely manner. After a long discussion the City Attorney and I came up with the idea that if we gave

them a two-week extension, this could potentially get done in that timeframe and we're not really out of anything, because it is a long process to go through the seizure process on the property. It is in the best interest of the City expenses, and also the individual being able to retain their land. I did speak to Miss Ortega just the other day, and I would like her to come up because she said that she'd be able to present an invoice and other documentation and stated they would have this accomplished by the 24th of July.

City Attorney Arabia stated the one thing I want everyone to keep in mind is just the time issue. This came up almost two weeks ago so two weeks sounds really short, but it was really a month because at the time we kind of said, Look, what we're going to ask the Council to do is give you until July 24th so we are not just springing that on them today, potentially and with the glacial pace of litigation, we thought this was appropriate. It gives them one final opportunity, and we would love to see them take advantage of it.

Sam Bida, Jr. stated we have up to date pictures of the property that were taken today.

Mayor Robertson stated, "If you will give those to the Clerk."

Lisa Ortega stated we just wanted to make sure that we brought the pictures. We do appreciate the extension, and we do appreciate the work by Levi Garcia that happened today. It's something to be local and to be able to come to the offices and talk about things; It's kind of different being in Vegas, It's a little bit harder. I do have an estimate and the 24th will be plenty of time. We are working with Paul with Out West Excavating and Grading. He said it would only take a day or so and it should not be a big deal. I want to ask, does this negate the eminent domain seizure from last month, or am I tearing the house down and the seizure is still in place? I want to make sure I'm not wasting my money.

City Attorney Arabia stated the deadline is July 24th and I can assure you, without any hesitation, that we are not going to wait for you to clear it, and then come in twirling mustaches and take the place; that's not what we're going to do and that's not what we're interested in. We told you that if you could get this done by a certain time we would back off and that's what we're going to do.

Lisa Ortega stated I appreciate that, and I do appreciate Levi's negotiating skills with the City; he was helpful. I also want to say that since you voted on it last time, we have moved four cars, and we have cleaned it up. The pictures that you saw from staff made the front page of the paper. They were three years old, and I feel like you should visit the properties that are in front of you before they come in front of you and make sure that the things that you see are accurate and timely.

Mayor Robertson stated we appreciate your attention to this, but this has been going on a lot longer than three years at this point.

Lisa Ortega stated since the last letters we received from the City we have had straight progress.

Councilman Trask moved to approve granting an extension through July 24, 2025 to Sam L. Bida to demolish the condemned structure per condemnation order dated April 15, 2024. Councilman Perea seconded the motion. The motion carried unanimously.

10. PUBLIC COMMENT:

Sam Bida Sr. stated I have been ill for the last ten years, and I haven't been able to clean up the property and so I dumped it on my son. I want to thank you guys for giving us this time.

George Chachas stated ongoing concerns regarding a copy of the letters that the City sent to Ralph Jones, Tina Templer, Elaine Blackham, Chris Walker, and Jane Montgomery outlining the

terms for consideration to write-off penalties and interest on their properties; the Contract Change Order for the Bell Avenue Project and the damage to his property not being addressed; his request for the address and a contact name regarding the Bell Avenue Water Main Upgrade Project CDBG 22/pf/04 and who inspected the project; who approved the 785 Bell Avenue Sewer Project; the sewer problem he took care of at his residence located at 681 Parker; City employees need to review the Title VI plan; Code violations by members of the Planning Commission, some City Council Members, some County Commissioners, and staff; 582 North Highway 93 property hooking up to City sewer, water, and has not put in a fire hydrant; the drainage off of the Bath property draining onto his property at 622 High Street causing erosion; and his request for a complete list of properties and individuals that the City has permitted and allowed to park RVs on the City lots and streets while living in them. Mr. Chachas also stated on June 24, 2025 you interviewed Michelle Yeoman at the Prospector. Did you also interview the other two candidates under the same condition? The selective stuff's got to stop.

Russell Greer stated I am here from Las Vegas, and I just wanted to say thank you for clarifying the ordinance. My LLC is talking about buying the land, and so I just appreciate that you clarified that for us.

Kerri Pintar stated I'm just dialing in. I'm in receipt of a picture of many of you on June 24th interviewing that councilwoman, I would have thought with the situation that went on with the County Commissioners you guys would think better of that because it stirs up a lot of emotions for people when they see you blatantly disregarding what was likely an Open Meeting Law violation, that's the woman that you appointed. My last comment is, where is she? You've got Mr. Saunders going to these meetings on a regular basis. You appointed her last week, and she's gone today. I think that was a poor choice, and I think it was a very poor choice for all of you to go to Margaritas. My God, choose a different restaurant that doesn't have such a wide viewing. That's the same place I caught the county commission and now here you guys are following suit. I'm very disappointed, so I hope you learn from it. You will get away with it, because no one heard what you were saying, but the look and the impropriety of it all is just beyond what you should be doing, and you guys should be ashamed of yourselves. Thank you.

11. ADJOURNMENT: THE MEETING MAY BE ADJOURNED BY APPROPRIATE MOTION OF THE CITY COUNCIL.

Councilwoman Williams-Harper moved to adjourn the regular meeting of the Ely City Council at **6:36 p.m.** Councilman Perea seconded the motion. The motion carried unanimously.
