Sealed proposals will be received by the White Pine County RTC at the Office of the County Clerk, 801 Clark Street, Ely, Nevada 89301, for the construction of the **Murry Street Paving Project 2021, PWP# WP-2021-335**, for the City of Ely, a White Pine County Regional Transportation Commission (RTC) funded project, until 2:00 P.M., P.D.S.T., on Tuesday, July 6, 2021, Proposals received after that time will not be accepted. Bidders mailing bids assume the risk of late delivery.

All bids shall be enclosed and sealed in an envelope and endorsed:

The submitted bids will be opened at the County Clerk's office immediately after the published deadline for acceptance of said bids, with County staff and at least one member of the Commission present as available. All interested parties are invited to be in attendance at the bid opening.

The RTC will formally award the submitted bids during their regularly scheduled meeting that begins at 8:00 A.M., P.D.S.T., on Wednesday, July 7, 2021, at a time indicated in the Published Agenda or as soon thereafter.

Bids must be on the proposal form provided by the RTC and must be accompanied by a bid bond, a certified check, a cashier's check or cash in the amount equal to at least FIVE PERCENT (5%) of total bid. All bonds including bid bonds shall be executed by a corporate surety company authorized to do business in the State of Nevada.

Plans, Form of Proposal, Contract and Special Provisions may be secured by bonafide intending bidders through the Office of Basin Engineering, 1070 East Aultman Street, Ely, Nevada 89301, and in each case a charge of fifty dollars (\$50.00) will be charged for each set. **THESE CHARGES ARE NON-REFUNDABLE.**

The attention of the bidders is directed to the State Contractor's License law that a contractor hold a valid license, at the time of bidding, of a class corresponding to the work to be done. Bidder shall also hold a valid City and County Business License before commencing construction.

Minimum wage rates have been determined by the Labor Commissioner of the State of Nevada and are set forth in the Contract Documents. In no case shall the wage rates be less than prescribed therein.

The County and RTC reserves the right to accept or reject any or all items specified in the bid request, as is deemed in the best interest of the County and RTC. The County and RTC reserves the right to waive any minor technicalities in the preparation of these bidding documents or specifications.

The award may be made to the lowest responsive and responsible bidder. The lowest responsible and responsive bidder will be judged on the basis of price, performance to specifications, bidder's qualifications, quality and utility of services, supplies, materials or equipment offered and their adaptability to the required purposes and the best interest of the public, each of such factors being considered.
