

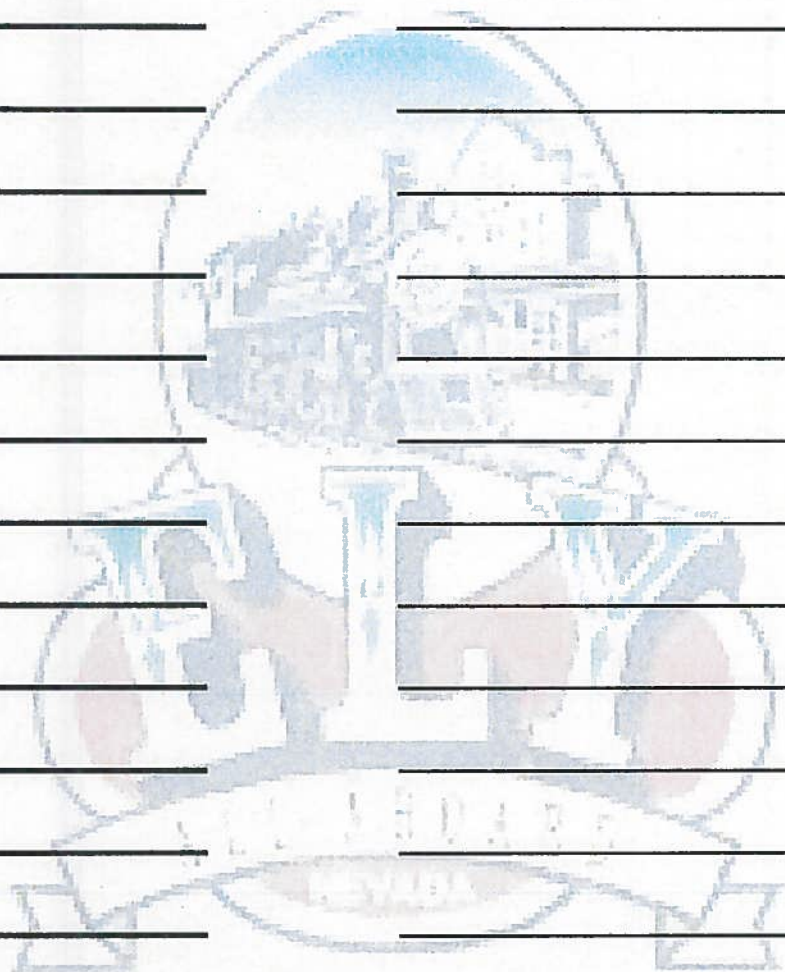

Dear Andrew Hayes,

Humane Network is pleased to inform you that Maddie's® Pet Project in Nevada (MPP-NV) has approved a grant in the amount of \$25,000 (the "Grant") to City of Ely Animal Control to support the execution of the work indicated below in this letter. Payment of the Grant is subject to the terms and conditions described more fully below.

Funding of Grant

Humane Network will fund the Grant at the above amount within 10 days after we receive from your organization a countersigned copy of this grant agreement letter.

Source and Management of Grant Funding

This grant is made possible through the generosity of Dave & Cheryl Duffield Foundation, a private charitable foundation based in Lake Tahoe, Nevada.

Humane Network, a Nevada-based nonprofit organization founded in 2007, manages the Maddie's® Pet Project in Nevada campaign.

Use of Grant Funds

City of Ely Animal Control agrees that all grant monies received and any income derived from these funds ("Grant Funds") will be used only to support the programs outlined below as your organization's participation in the Maddie's® Pet Project in Nevada campaign. Grant Funds may not be used for any other purposes without the prior written approval of the executive leadership of Humane Network.

Grant Reporting Requirements

City of Ely Animal Control agrees to submit full and complete reports to Maddie's® Pet Project in Nevada/Humane Network, which describe how the Grant Funds have been spent. The report will cover the period that runs from the date of this funding through September 30, 2019 and will be submitted to MPP-NV/HN no later than November 15, 2019. Thereafter, City of Ely Animal Control will submit an annual report for each subsequent 12-month period as measured from October 1, 2018 – September 30, 2019 in which City of Ely Animal Control retains or spends any Grant Funds. Such annual reports will be submitted to the Foundation within 45 days following the last day of the period covered (i.e., by November 15), until all Grant Funds have been expended in full. Reports will contain a narrative and budget-to-actual that describe how the Grant Funds were spent and examples of how Dave & Cheryl Duffield Foundation and Maddie were recognized.

Data Reporting Requirements

City of Ely Animal Control agrees to provide directly to Maddie’s® Pet Project in Nevada/Humane Network, their comprehensive animal data for all dogs and cats taken into the care of the organization and/or receiving spay/neuter services for the years of 2017, 2018 and 2019. An additional modest grant will be provided to cover the costs of providing this data. The data for 2018 will be provided no later than March 1, 2019. And the data for 2019 will be provided no later than March 1, 2020.

City of Ely Animal Control also agrees to post accurate current data to Shelter Animals Count for 2017 and ongoing through 2019.

Grant Funding

Public spay/neuter services, TNR: \$10,000

Increase pet adoptions locally to improve live release from shelters: \$15,000

This grant of \$25,000 is to be used in the following manner: \$15,000 to increase pet adoptions locally to improve live release from the shelters. Funds may be used for marketing and promotion of pet adoption, cages and animal care supplies, spay/neuter and vaccination for animals in the shelter, so long as these expenditures result in increased live release rates. \$10,000 is to support the TNR program for feral cats and to otherwise provide spay/neuter services. The TNR program should get top priority for funding from this grant.

The grant report should provide statistics on the number of animals served as well as a few narrative stories of people and their pets who are helped, and photos will be greatly appreciated by the funders.

Recognition and Trademark

City of Ely Animal Control agrees that in consideration of this grant, the organization will fully implement the Maddie's® Pet Project in Nevada Grant Recognition Plan attached to this letter agreement. Accordingly, Dave & Cheryl Duffield Foundation hereby grants City of Ely Animal Control a limited, non-exclusive, non-transferable license solely to use the Foundation's name and any logo provided to your organization in providing such recognition and benefits. No alteration may be made to the Foundation's logo, including, without limitation, any alteration to the color, typeface or any elements of the logo's design without the prior written approval MPP-NV/HN. City of Ely Animal Control further agrees that it will not use the Foundation name or logo in any way which would have a reasonable possibility of damaging the goodwill built up in the marks or disparaging or impugning the reputation of the foundation and/or its affiliated entities.

All use of the Foundation’s logo and name will inure to the benefit of the Foundation and will also be subject to the reasonable guidelines and limitations set by the Foundation from time to time. In addition, the quality of any goods and services provided in connection with or having any relation to the Grant Funds will be at a high level consistent with industry standards and at least commensurate with the quality of any goods or services previously rendered by City of Ely Animal Control. The Foundation name and logo may not be used in any manner that is likely to cause confusion in the public, for example, suggesting a closer relationship with, affiliation with, sponsorship by, or endorsement by the Foundation than actually exists.

If this license or this entire agreement is not terminated sooner, the term of the license shall be one year from the date of this letter. The license shall be automatically renewed for successive one-year terms at the end of each such term, unless the Foundation gives notice of its election not to renew the license at

least ninety (90) calendar days prior to the end of a term, or terminates the license for non-compliance as set forth below. The Foundation may terminate the license of its name and marks granted herein with ten (10) calendar days' notice at any time if the Foundation determines that City of Ely Animal Control is not in compliance with this agreement, or if the Foundation determines in its sole and absolute discretion that allowing continued use of such name or marks by City of Ely Animal Control in any way damages the goodwill built up in such name or marks, disparages or impugns the reputation of the Foundation and/or its affiliated entities, or exposes the Foundation and/or its affiliated entities to undesired legal or business risks or liability.

City of Ely Animal Control acknowledges and agrees that the Foundation owns all right, title, and interest, including without limitation all trademark and other intellectual property rights associated with its name and logo. City of Ely Animal Control agrees to cooperate with Maddie's® Pet Project in Nevada, Humane Network and Dave & Cheryl Duffield Foundation in facilitating the Foundation's control of the nature and quality of the use of the foundation's name and logo as well as the images of Maddie and to permit reasonable inspection of the use of these marks or to supply specimens of all uses of the logo, name and image of Maddie upon request.

Indemnity

In consideration of this grant, City of Ely Animal Control agrees to indemnify, defend, and hold harmless Dave & Cheryl Duffield Foundation, and its affiliates, agents, officers, trustees, employees, directors, consultants, and other persons related to or acting on behalf of Dave & Cheryl Duffield Foundation (including Humane Network and Maddie's® Pet Project in Nevada) from and against any and all losses, liabilities, damages, costs, claims, attorneys' fees, and expenses arising out of, or in any way related to (1) this grant or any previous or future grants made to Dave & Cheryl Duffield Foundation or any of its affiliates by Dave & Cheryl Duffield Foundation; (2) any facility, equipment, or vehicle owned, operated or managed by City of Ely Animal Control; (3) the use by City of Ely Animal Control of any name or mark of the Foundation; (4) any programs, activities, or equipment which the Grant may fund, in whole or in part; or (5) any acts or omissions by or on behalf of City of Ely Animal Control, or any of its affiliates, agents, officers, trustees, employees, consultants, or other persons related to or acting on behalf of City of Ely Animal Control.

Remedies

City of Ely Animal Control agrees to immediately repay to the Humane Network/Maddie's® Pet Project in Nevada Campaign any portion of Grant Funds which is spent or committed for any purpose other than the agreed upon purpose outlined above in this document. If Dave & Cheryl Duffield Foundation or Humane Network, in their reasonable discretion, determines that City of Ely Animal Control has substantially violated or failed to carry out any provision of this letter agreement, including but not limited to failure to submit adequate reports when due, they may, in addition to any other legal remedies that may be available, refuse to make any further grant payments to City of Ely Animal Control under this or any other grant agreement, and may demand the return of all or part of the grant funds not properly spent which City of Ely Animal Control shall immediately repay. City of Ely Animal Control acknowledges and agrees that Dave & Cheryl Duffield Foundation and Humane Network shall have the legal standing necessary to bring any suit it deems necessary to enforce the terms of this grant agreement letter.

General Provisions

Dave & Cheryl Duffield Foundation or Humane Network/Maddie's® Pet Project in Nevada may review financial and other records and materials connected with any equipment purchased or activities financed by this grant.

By countersigning this letter, you represent that City of Ely Animal Control is either:

___ a.) a government run animal shelter that agrees to utilize the funds specifically for the purposes outlined in this document.

___ b.) a tax-exempt Section 501(c)(3) organization, in accordance with the Internal Revenue Code of 1986 and amendments thereto ("IRC"), and that City of Ely Animal Control is a public charity defined in IRC section 509(a)(1) and/or 509(a)(2). (City of Ely Animal Control agrees that it will not do anything to jeopardize its public charity status under IRC sections 501(c)(3) and 509(a) and further agrees to notify the Foundation immediately should City of Ely Animal Control's status with the Internal Revenue Service ("IRS") change, or should the IRS or any state taxing authority challenge such status.

___ c.) a Nevada incorporated non-profit organization that agrees to utilize the funds specifically for the purposes outlined in this document.

City of Ely Animal Control will not use any Grant Funds to carry on propaganda or otherwise attempt to influence legislation. City of Ely Animal Control also agrees not to use the Grant Funds to influence the outcome of any specific public election, or to carry on, directly or indirectly, any voter registration drive.

This letter agreement constitutes the entire agreement between the parties and supersedes any prior oral or written understandings, communications, and representations. This agreement may be signed in counterparts and may be amended or modified only by a written document executed by duly authorized representatives of City of Ely Animal Control and Humane Network. The failure by Humane Network to exercise or enforce any right under this agreement, or the waiver of any such right at the time it arises, shall not operate as a waiver of the organization's right to exercise or enforce such right or any other right in the future.

If this letter correctly sets forth City of Ely Animal Control's understanding of the agreement with Humane Network/Maddie's® Pet Project in Nevada regarding this \$25,000 grant, please countersign this letter at the place indicated below and return it to Humane Network.

On behalf of all of us at Maddie's® Pet Project in Nevada and Humane Network, we wish City of Ely Animal Control the best of success in its important work on behalf of the animals of Nevada.
