The meeting may be closed by appropriate motion for the purpose of discussion on any matter allowed under N.R.S. 241.031 and 241.033, (1) nothing contained in this chapter prevents a public body from holding a closed meeting to consider the character, alleged misconduct, professional competence or physical or mental health of a person/employee. (2) A public body may close a meeting upon a motion, which specifies the nature of the business to be considered. (3) This chapter does not: (a) Apply to judicial proceedings. (b) Prevent the removal of any person who willfully disrupts a meeting to the extent that its orderly conduct is made impractical. (c) Prevent the exclusion of witnesses from a public or private meeting during the examination of another witness. (d) Require that any meeting be closed to the public. (e) Permit a closed meeting for the discussion of the appointment of any person to public office or as a member of a public body. (4) The exception provided by this section, and electronic communication, must not be used to circumvent the spirit or letter of this chapter in order to discuss or act upon a matter over which the public body has supervision, control, jurisdiction or advisory powers.

To Whom It May Concern:

It has come to the attention of the White Pine County School District Board of Trustees that the Learning Bridge Charter School has filed an application for financial assistance with the USDA--Rural Development in order to build a school facility. This letter is provided to the City Council as feedback to be considered as the Council determines whether to issue a "Certificate of Support."

It should be noted that as a "local government unit," the WPCSD was not contacted with the same letter provided to the City to provide any support or feedback. Given that the WPCSD is clearly a "community facility providing similar services," the WPCSD finds this to be somewhat concerning.

This letter is not a criticism of any Learning Bridge staff, personnel, or the school itself. It is merely a statement of "adverse impact" as described in the letter provided to the City. The feedback is coming directly from the local government unit currently experiencing said adverse impact, namely the White Pine County School District, which is a "community facility providing similar services"--education.

The WPCSD experienced a 20% budget reduction in 2016 as a result of the final year of a "hold harmless" provision for declining enrollment. This reduction resulted in the elimination of programs directly serving students: Career and Technical Education programs at White Pine High School, elective programs at White Pine Middle School, specials programs such as music, art, PE and others at the elementary level. Additionally, the community fundraised more than \$60,000 in 2016 simply to keep athletic programs from being cut. To date, few of these programs have been fully reinstated. Those that do exist do so because of grant funding and significant fundraising. The WPCSD's adverse impact continues into 2019 to the tune of approximately \$1.7 million per year.

These cuts and continued impact are directly correlated to the number of students who attend Learning Bridge and are provided education outside of the WPCSD. The \$1.7 million difference

per year is based on the per pupil allocation (including both state and local revenues) provided to Learning Bridge because that is where the students are attending school.

Meanwhile, the WPCSD continues to have fixed costs that must be maintained despite serving fewer students. Transportation and athletics are just two of them. The WPCSD must continue to run the same bus routes each day despite having fewer students. Because this is a fixed cost, it forces the district to make cuts elsewhere. Similarly, running athletics programs is incredibly expensive, yet something the community and parents expect. Despite having \$1.7 million per year less to spend, the district has maintained these programs because they are great for kids. But the cost of running the programs doesn't decrease simply because there are fewer students in the district. Running buses to every corner of the state, paying officials and coaches, purchasing equipment—these are all costs that are fixed (at best—usually they increase each year)—which results, again, in cuts being made elsewhere.

If this adverse impact were not in place, district schools would be able to offer the more robust programs listed above (as well as others) without reliance upon grants and fundraising. These more robust programs would benefit all students, whereas building a new school for Learning Bridge benefits only the students who attend there.

The WPCSD asserts that building a new school for Learning Bridge will continue to have an adverse effect upon another community facility which provides similar services, namely the school district.

It is not the intent of the WPCSD to sabotage Learning Bridge's efforts at providing educational services; but it is the intent of the WPCSD to communicate the negative fiscal impact of operating two different school systems in such a small community.

Dear Chuck:

As we have discussed matters on the telephone and sometimes details get lost in the cracks I thought I would give you a view of the big picture as I see it as of today.

We seek temporary operation under the present licensee so that the Silver State Classic event and the White Pine Motorcycle Rally both occur as planned.

Both the Silver State Classic and the White Pine Motorcycle Rally should be successful events bringing entertainment, tourists and revenue to Ely.

Assuming we are allowed to proceed, during the events I would anticipate having a picnic type atmosphere in the outside area with plenty of outdoor cooking, including hamburgers, hotdogs and baked beans. The beer garden will be iced down. We anticipate a lot of fun. If we are able to secure musical entertainment, that will be fun as well. Feel free to come, look around, have some food and a drink and see how we are doing during these events.

The status of the facility as of today is closed, as it has been since Saturday night 29 April 2019.

A complete clean-up, inside and out is, or soon will be, underway. The gentleman that you met (Robbie) and our bartender (Jacqueline) are involved with that process. As we get closer to our two events and assuming we are allowed to operate, the Stardust will be in good shape for the events.

We have identified two very suitable candidates for Prostitution licensing.

Robbie is presently the designated manager and will be on site during hours of operation.

There is one more gentleman, Gary Phillips, who will also act as manager. Gary is the prospective applicant for licensing and is new owner. Gary is a property owner in Ely, having recently gone through a Probate process in Ely on behalf of his brother's estate.

We invite the While Pine County Sheriff's office to stop in and inspect, look around, bring narcotics dogs to go through the property any time and for so long as Stardust operates and for so long as it takes for the White Pine County Sheriff's office, yourself, the Mayor and the council to become comfortable with the Stardust's operation.

The personnel that were engaging in drug related activities are gone, never to return. I personally admonished those that visited the Stardust looking for those persons to leave the Stardust and to never return. In each case, there was compliance. A zero tolerance drug policy will be vigorously enforced.

I will provide a list of those employees that were affiliated with the Stardust but are no longer present or welcome. I will provide a list of newly licensed employees and we will keep that list current and updated for so long as the Stardust operates.

I am going to see that we maintain a healthy facility and that we comply with the laws and regulations in Ely. Moreover, we will strive to make the Stardust an asset to the community.
