The meeting may be closed by appropriate motion for the purpose of discussion on any matter allowed under N.R.S. 241.031 and 241.033, (1) nothing contained in this chapter prevents a public body from holding a closed meeting to consider the character, alleged misconduct, professional competence or physical or mental health of a person/employee. (2) A public body may close a meeting upon a motion, which specifies the nature of the business to be considered. (3) This chapter does not: (a) Apply to judicial proceedings. (b) Prevent the removal of any person who willfully disrupts a meeting to the extent that its orderly conduct is made impractical. (c) Prevent the exclusion of witnesses from a public or private meeting during the examination of another witness. (d) Require that any meeting be closed to the public. (e) Permit a closed meeting for the discussion of the appointment of any person to public office or as a member of a public body. (4) The exception provided by this section, and electronic communication, must not be used to circumvent the spirit or letter of this chapter in order to discuss or act upon a matter over which the public body has supervision, control, jurisdiction or advisory powers.

2. PUBLIC COMMENT:

George Chachas stated I've asked for time and date stamped bids for the Georgetown Ranch lease bids. Has the sewer line been completed on Avenue A? At the Regional Planning Commission meeting they gave the Golf Course 3.5% of the room tax. On the Dec 13th, 2019 billing, the City paid the Reck Brothers for patching at Copper Queen, why are you paying for maintenance on private property? I want to know what happened to the four hundred ninety linear feet of sixteen inch steel pipe from the Murry street project. I have yet to be reimbursed by the City for curing a sewer problem at 681 Parker Avenue.

Frederick Partey stated I have been out of the Country so I just wanted to let the Utilities Board know that I'm back and I'm here to answer any questions. I received an estimate on the work that needs to be done on the Terrace Well; I spoke to our management team and we are thinking through it and setting up meetings to discuss everything. Pump 7-P is still continuing to pump water to the City, its pumping around 2,100 GPM. Plans are in place to get a new pump.

ARTICE XIII

OTHER CONTRACT TERMS

Section 13.0. Amendments. Amendments or modifications to this Agreement may be made from time to time in writing as approved by the Parties hereto and pursuant to NRS 241.

Section 13.1. Termination.

- (a) During the first year of this Agreement, the parties agree that neither party may terminate this Agreement, except for breach of the Agreement by failure to pay compensation as required herein, or the City failing to provide the aid contemplated by this Agreement and only after the non-breaching party has notified the breaching party of the breach and the time to cure, which shall be thirty (30) calendar days from the date of written notification of the alleged breach by the non-breaching party to the breaching party of their alleged breach sent by certified mail or personal delivery to the address provided in Section 13.5.
- (b) Starting July 1, 2020 this Agreement shall be reopened for renegotiation of terms, or for possible termination, upon twelve (12) months written notice to each party. Termination cannot occur until the completion of the fiscal year, meaning, to terminate the Agreement on June 30, 2021, the party wishing to terminate the Agreement must notify the other party no later than July 1, 2020.
- Section 13.2. Execution of Additional Instruments. Each Party at the request of the other party, shall execute, acknowledge, and deliver any document, instrument, or conveyance that is or may be necessary to carry out the provisions of this Agreement.

SECOND AMENDMENT TO DEVELOPMENT AGREEMENT

Nevada Northern Railway Foundation, Inc., formerly known as White Pine Historical Railroad Foundation, Inc., a Nevada nonprofit corporation (the "Foundation") and the City of Ely, Nevada, a Nevada municipal corporation (the "City"), entered into a Development Agreement effective as of July 11, 2016 (the "Development Agreement").

The Foundation and the City amended the Development Agreement effective as of June 1, 2019 (the "First Amendment to Development Agreement"). The First Amendment to Development Agreement extended the initial term of the Development Agreement by one (1) year, from July 11, 2019, to July 11, 2020, by amending Section 7 of the Development Agreement.

The Foundation and the City now desire to again amend the Development Agreement as set forth below (the "Second Amendment to Development Agreement"). This Second Amendment to Development Agreement is effective as of June 1, 2020. This Second Amendment to Development Agreement may be executed in one or more counterparts, each of which shall be deemed and original, but all of which together shall constitute the same instrument. A facsimile or electronic copy of this Second Amendment to Development Agreement or its signature page shall be excepted as an original. This Second Amendment to Development Agreement shall be construed in accordance with and governed by the laws of Nevada.

The parties acknowledge and agree that the purpose of the this Second Amendment to Development Agreement is to extend the Initial Term to April 1, 2021.

The first sentence of Section 7 of the Development Agreement is amended as follows (new language in **bold**, deleted language stricken):
