The meeting may be closed by appropriate motion for the purpose of discussion on any matter allowed under N.R.S. 241.031 and 241.033, (1) nothing contained in this chapter prevents a public body from holding a closed meeting to consider the character, alleged misconduct, professional competence or physical or mental health of a person/employee. (2) A public body may close a meeting upon a motion, which specifies the nature of the business to be considered. (3) This chapter does not: (a) Apply to judicial proceedings. (b) Prevent the removal of any person who willfully disrupts a meeting to the extent that its orderly conduct is made impractical. (c) Prevent the exclusion of witnesses from a public or private meeting during the examination of another witness. (d) Require that any meeting be closed to the public. (e) Permit a closed meeting for the discussion of the appointment of any person to public office or as a member of a public body. (4) The exception provided by this section, and electronic communication, must not be used to circumvent the spirit or letter of this chapter in order to discuss or act upon a matter over which the public body has supervision, control, jurisdiction or advisory powers.

^{*} Open session - Action/Discussion - Personnel**

Summary: An ordinance amending Chapter 5 of Title 1 of the City Code of the City of Ely requiring the City Council to create a code of conduct for its members to apply during city council meetings and interactions with city personnel, to include following the chain of command.; proscribing that violation of the Code of Conduct constitutes cause within the meaning of NRS 266.240.

TITLE:

PROPOSED ORDINANCE AMENDING CHAPTER 5 OF TITLE 1 OF THE CITY CODE OF THE CITY OF ELY REQUIRING THE CITY COUNCIL TO CREATE A CODE OF CONDUCT FOR ITS MEMBERS TO APPLY DURING CITY COUNCIL MEETINGS AND INTERACTIONS WITH CITY PERSONNEL, TO INCLUDE FOLLOWING THE CHAIN OF COMMAND.; PROSCRIBING THAT VIOLATION OF THE CODE OF CONDUCT CONSTITUTES CAUSE WITHIN THE MEANING OF NRS 266.240.

Whereas, NRS 266.240 provides that the City Council shall determine its own rules of procedure, may punish its members for disorderly conduct, and, with the concurrence of two-thirds of the members of the city council, may expel a member for cause;

Whereas, NRS 266.200 provides that the Mayor of the City of Ely shall preserve order and decorum among the members of the City Council and enforce the rules of the City Council;

Therefore, the City Council of the City of Ely, State of Nevada, does <u>AMEND</u> and otherwise ordain that the sections of Chapter 5 of Title 1 of the City Code of the City of Ely specified below shall read as follows:

1-5-7: CONDUCT OF THE CITY COUNCIL:

The City Council shall adopt a Code of Conduct for its members to apply during city council meetings and interactions with city personnel, to include following the chain of command.

1-5-87: SALARIES OF ELECTED OFFICIALS:

A. Mayor:	The s	salary	of the	mayor	shall l	be set	at six	hundred	dollars	(\$600.00)	per
month.											

B. Councilmen: The salaries of each respective city council member shall be set at five hundred dollars (\$500.00) per month. (Ord. 518, 6-12-1997)

SEVERABILITY: 2-5-<u>9</u>13:

If any provisions of this Ordinance are held invalid, such invalidity shall not affect other provisions and each provision is hereby declared to be severable.

This Ordinance shall take effect from and after passage, approval, and publication.

RESOLUTION 2020-5

A RESOLUTION ESTABLISHING REQUIREMENTS OF A CONDITIONAL SPECIAL USE PERMIT TO ALLOW EXISTING MOBILE HOME PARKS WITHIN THE CITY OF ELY TO HAVE RV TRAILERS AND MOTOR HOMES PARKED WITHIN THEIR CONFINES FOR TEMPORARY CONSTRUCTION WORKERS

WHEREAS, N.R.S. 266.105 empowers the Ely City Council to pass resolutions necessary or proper for the municipal government and the management of the affairs of the city, for execution of all powers vested in the City; and

WHEREAS, this resolution shall adopt the following requirements:

- 1. Each Mobile Home Park shall provide the number of spots available for the Special Use Permit at the time of application.
- 2. Each Mobile Home Park shall pay a \$150.00 annual fee for the first year. Each subsequent year with the same tenant(s) shall have an annual fee of \$100.
- 3. Approval by City Building Official of Mobile Home Park's RV hook ups prior to issuance of Special Use Permit.
- 4. RV Trailers and Motor Homes shall follow all rules and regulations within the Park.
- 5. Each Mobile Home Park owner is required to maintain annual employment records with the City for tenants who are actively employed with temporary contractors in the City of Ely and residing within the Park under the Special Use Permit.
