THIS AGREEMENT, made and entered into this _____ day of _______, 2020, is between the City of Ely, a municipality incorporated in the County of White Pine, State of Nevada, by and through the Mayor and City Council, hereinafter referred to as "the City" and Basin Engineering, hereinafter referred to as "Consultant."

WITNESSETH:

WHEREAS, amendments to the Standard Agreement may be made in writing as approved by the Parties; and

WHEREAS, on March 12, 2020, the Governor of Nevada issued a Declaration of Emergency to facilitate the State of Nevada's response to the COVID-19 pandemic;

WHEREAS, on March 20, 2020, the Governor of Nevada ordered all non-essential businesses in the State of Nevada to close in order to limit the spread of the novel corona virus;

WHERAS, on March 31, 2020, the Governor of Nevada extended the Declaration of Emergency and shelter-in-place orders through April 30, 2020;

WHEREAS, the City predicts the COVID-19 pandemic will have a financial impact on its annual revenues; and

NOW THEREFORE, in consideration of the mutual promises and covenants herein, the Parties agree as follows:

- 1. Effective June 13, 2020, the monthly flat fee for each year shall be cut by 12.5%.
- 2. The Parties agree that non-time sensitive projects may be completed over a larger period of time.
- 3. The Parties shall meet every two (2) months to review and discuss the financial impact of the COVID-19 pandemic on the City, and the continued necessity for this MOU.

4. This MOU shall expire no later	than June 30, 2021.

Ely City Council, Public Comment:

Good evening, my name is Cheyenne Gibson and I am a regional coordinator with the Nevada Census 2020 Outreach team. I wanted to take this opportunity to give the Ely City Council a census update.

Nevada's response rate is 59.4%. The City of Ely response rate is 50.8%. White Pine County response rate is 37.8%.

The U.S. Census Bureau has begun its update leave operation, where 2020 Census forms are hand-delivered to residences that either do not have mail delivered to the physical location of the home, or the mail delivery information for the residence cannot be verified. This process is to ensure all Nevadans — particularly in rural communities — are counted. Once the paper forms begin to be submitted there should be a jump in our response rates.

There will be no contact between census employees and household members during the Update Leave process. Forms will be left at the residence.

All of us will be receiving our paper form, if we haven't already. If you have already filled out your census online or by phone, the paper form can be disregarded. Any reminders that come in the mail can also be disregarded.

A large majority of White Pine County and the City of Ely still needs to be counted. We have until the end of October 31st, 2020 to self-respond.

In light of public health concerns, we continue to encourage our communities to complete their census from the safety of their homes. As community leaders and trusted voices, you can help by:

- Achieving a 100% response rate from your agency.
 - o If your agency reached 100%, send me an email and our team will shout your out on our social media platforms!
- Highlight the 2020 census in your agency e-mails, bulletins, newsletters, and mailings to increase awareness of why the census important.







STREET DEPARTMENT

During the month of May the street department picked up 2 loads of crs-2 from North Salt City to be used in dura patch and cold mix projects. We dura patched in several areas throughout Ely. We skim patched a rough section to tie into a skim patch on Avenue C that we had previously patched with cold mix. We also paved over a block on Strandman Street that was mostly dirt using cold mix. We crack sealed streets in Ruth to prep for the planned slurry seal project this summer. We owed the county hours from last summer and the crack sealing brought our hours close to even. We also had a demonstration of an Elgin mechanical street sweeper between us and the county road department as a possible future joint purchase through the RTC. During June we will receive a demonstration of a Johnston mechanical sweeper to compare with it. Also in June we plan to dura patch roads for the county road department to trade hours for anticipated hours the county will use in some upcoming chip seal jobs.
